



HORIZONS GOLD YIELD FUND ANNOUNCES JUNE 2011 DISTRIBUTION

TORONTO, June 20, 2011 - Horizons Exchange Traded Funds Inc. (“**Horizons ETFs**”) and its affiliate AlphaPro Management Inc. are pleased to announce the monthly distribution of the Horizons Gold Yield Fund (the “**Fund**”) for June 2011 in the amount of \$0.0542 per Class A unit and Class F unit of the Fund. The Class A units of the Fund are listed for trading on the Toronto Stock Exchange (“**TSX**”) under the symbol **HGY.UN**. The Class F units of the Fund are not publicly listed. The monthly distribution is payable on July 12, 2011 to Class A and Class F unitholders of record on June 29, 2011.

The Fund’s investment objectives are to provide unitholders with: (i) exposure to the price of gold bullion hedged to the Canadian dollar, less the Fund’s fees and expenses; and (ii) tax-efficient monthly distributions. It is expected that monthly distributions currently received by unitholders will consist primarily of return of capital.
